Important Covid19-related information on access to Spain and Circuit de Barcelona

1. Access to Spain

There are no specific restrictions to enter Spain, but we advise citizens and/or residents in countries outside Europe to make a check with their Embassy/Consulate in Spain or the Spanish Embassy/Consulate in their country.

The **only mandatory formality for all individuals entering Spain** is to fill the **FCS form** in the 48 hours prior their arrival to the country.

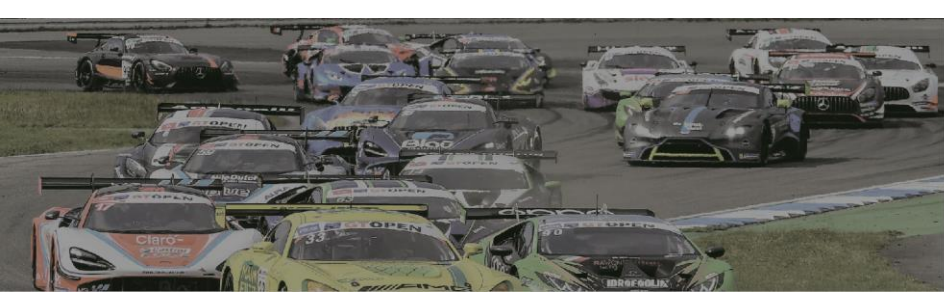

2. Access to the Circuit

Like in Spa, all individuals entering the Circuit de Barcelona-Catalunya will have to show the **negative result of a Covid-19 PCR test performed not earlier than 96 hours** prior to arrival at the track. They will then receive a bracelet authorizing his/her attendance to the event.

We draw everybody's attention to the fact that this requirement is mandatory for any person attending the event, regardless of his/her function or capacity and citizenship/country of residence (**Spanish citizens and residents included**).

In order to ease the process, please list your personnel (including drivers, accompanying persons and possible guests) in the attached (**Attch 1**) form and return it by Friday 23 October to almudena.coppel@gtsport.es



Shortly we will inform of the plan for the Accreditation Center where the check will be performed. However It will operate according to the following timetable:

Wednesday 08h00 = 17h00

Thursday 08h00 – 17h00

Friday 08h00 -17h00

Saturday 08h00 a 14h00

In addition, you will have to fill and hand out the standard Auto-certification document (**Attch 3**)

Should the Circuit provide us with invitation letters, we will make those available to whoever needs them.

3. Other important information:

- The Circuit has an agreement with two laboratories/pharmacies in Barcelona and Granollers that can perform PCR tests and provide results same day or 24/48 hours later, depending on the time of testing. This possibility should be used only as **last option**, should you have a problem to do the test in your country before departure. When contacting them, you should say you have been directed to them by GT Sport or Ambar.

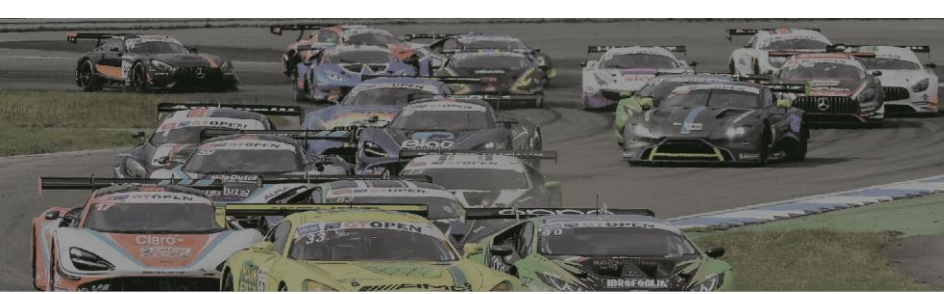

- In light of the fact that a number of countries require a **PCR test to individuals returning from Spain**, and in order to ease the inconvenience for all, we have organized the possibility to perform PCR tests at the track. The PCR station in the paddock will be available on **Saturday 31st October from 9 to 11 am**.
- We remind you that at present the entire autonomous region of **Catalonia is under a status of partial confinement, which includes closure of all restaurants and bars / cafés**, although a number of them can operate on a pre-order / take-away basis. We recommend you to take this aspect into account and to check if your hotel is authorized to serve food and in what way.
