With regard to the above, I the undersigned

**DECLARE THAT:**

2.  I am full-aged on the day this deed is signed, and my driving licence is valid;  
 I have not yet attained my majority on the day this deed is signed, but I have a regular;
3. I am aware of the regulations and cautions to be complied with by the users of the facility;
4. in connection with all the above, the above mentioned vehicle is perfectly suitable for the session I, the undersigned, intend to perform;
5. I enjoy perfect physical and mental health, thereby releasing ACI Vallelunga from any liability for any physical problem which might emerge during the session;
6. I have taken out an insurance policy against all accidents, renouncing the subrogation mentioned under article 1916 of the Civil Code;
7. I have duly read the tariffs and other conditions in force for the use of the facility, and accept them unconditionally;
8. I release the bodies owning the racing circuit Aci Immobiliare Automotive Spa, ACI Vallelunga S.p.A., and the staff working in the circuit from any liability issuing from the session I intend to perform;
9. I give the broadest security releasing ACI Vallelunga S.p.A. and the bodies owning the race circuit and ACI Vallelunga S.p.A. on my own behalf and on behalf of my successors and assignees by any right:
  - a. from any obligation whatsoever to pay to the undersigned any kind of compensation as damages, refunds, indemnification, reimbursement, etc., in the event of any accident – whatever its duration, result and consequences – that might occur, whatever its cause (including force majeure and fortuitous events) and whoever might be responsible for it (including the owners of the circuit, ACI Vallelunga S.p.A., its organization, its managers and personnel, any other party involved and, more generally, the parties mentioned in the articles 1228 and 2049 of the Civil Code;
  - b. from any claim laid in any capacity by third parties for events ascribable to the undersigned: said third parties include bodies, associations and individual persons present in the racing circuit
  - c. in any capacity, or anyway who have suffered damages due to events ascribable to the undersigned;
10. I renounce, in connection to what might happen, any claim against ACI Vallelunga S.p.A. and/or the owners of the racing circuit for damages in any way connected with the undersigned's entrance, stay or use of the facility;
11. the reimbursement of any damages produced directly or indirectly:
  - a. to the structures of the circuit;
  - b. to other drivers and their cars;
  - c. to third parties, either spectators or members of the organization;
 will be borne totally and exclusively by myself, the undersigned, who releases ACI Vallelunga S.p.A. from any liability in connection with the occurrence of the events mentioned under paragraphs. a., b., and c. and from the subsequent reconstruction, as well as from any claim for damages which might be laid against it by third parties for the above mentioned reasons.

I acknowledge that ACI Vallelunga S.p.a. is not responsible for thefts and/or damages to materials left in storage at the racing circuit, recognize that the parking places and the pits, including those inside the racing circuits, are unattended, and I bear full responsibility for the safekeeping and surveillance of any object brought into the racing circuit (including the car mentioned above) and therefore I assume full responsibility for the use of the above objects within the racing circuit and in its ancillary areas, and pledge to pay

compensation for any damage caused directly and/or indirectly to persons and/or things, without exceptions, both within the circuit and in its ancillary areas and structures;

12. I pledge to use the circuit at the conditions set forth in the general regulations which is an integral part of this statement for all legal effects, with the exception of any form of competition unless it is included in the type of session to be performed;
13. I pledge to perform a first lap of the facility with the purpose of checking its conditions and to inform timely ACI Vallelunga S.p.A. of any irregular condition. If no communications/remarks/criticism are expressed following the inspection lap, the conditions of the facility will be considered as tacitly approved. I, the undersigned further declare that I viewed the equipment and services of the circuit and that they meet my needs, and that I release the bodies owning the circuit and ACI Vallelunga S.p.A. from any financial or non-financial consequences possibly caused by accidents due to the conditions of the facility and of the equipment;
