Free practice sessions must be paid by bank transfer together with the registration.

Access to the free practice sessions permitted only upon signing of the relative liability waiver, available on Circuitenter portal.

C) GARAGE

1) GARAGE RESERVATIONS

The reservation request must be sent before September Thursday the 26th 2024 via CircuitEnter portal.

Garage reservations will not be considered unless submitted at the same time as the registration.

The assignment of the garages will be made by ACI Sport, who will communicate it to the Racing Office of Autodromo Nazionale Monza.

2) COSTS

We officially communicate that, due to this year's reworks of the circuit, the structure of the garages has changed: for this reason, each team will have to set up their own repartition of their allocated garage.

The cost for the entire Weekend (Friday, Saturday, and Sunday) of each garage is as follows:

3) PAYMENT

Payments can only be made in advance by Bank Transfer to the same bank details as the registration payment above, immediately after having received confirmation of the garage assignment.

4) KEYS' PICKUP AND RETURN

The garages will be made available as of 09.00 am on Thursday October 3rd 2024.

Keys can be collected at the Security Point (ph. 039 2482241), located at the entrance of paddock 1, upon completion of the relative forms.

5) SECURITY PROVISIONS WITHIN THE GARAGE:

- It is forbidden to either smoke or the usage of open flames inside the garages;
- It is forbidden to deposit inside the garages flammable materials (gasoline, etc.), which must be stored outdoors;
- Leave fire hydrants, fire extinguishers and any other fire-fighting equipment visible and accessible;
- Ensure that emergency exits, transit areas and escape routes are fully accessible, avoiding any obstruction;
- Deposit waste oils in the appropriate containers located at different points inside the Circuit;
- In case of accidental spills of flammable liquids, oils or substances that may make the pavements slippery, promptly remove and clean them.

6) GARAGE & PIT CLEANING

- It is prohibited to leave tires both inside and outside the garage at the end of the event;
- It is forbidden to apply stickers of any kind to the garage floor;
- Before returning the keys, garages must be freed of any material not present at the arrival;
- At the end of the event, any tape placed on the floor of the pit lane must be removed, to have a clean surface.
A fine of € 150 will be applied if the tape is not removed properly.

We remind you that there is a ban on the abandonment of special waste inside Autodromo Nazionale Monza.

Special waste (such as tires, carpeting, elastomers, batteries, brake discs, empty gasoline drums) must be removed from the facility and disposed of at the Customer's expense. Any cost of restoration and disposal will be charged by Sias S.p.A. to the responsible parties. Exhausted oils must be deposited in the appropriate containers located at various points within the paddock. Normal waste must be recycled in the appropriate bins located outside the garages.

D) TIMETABLE OF THE EVENT

1) TIMETABLE

The provisional timetable of the event will be published both on www.acisport.it and <https://www.monzanet.it/en/>.

2) ADMINISTRATIVE CHECKS:

The administrative checks will be held exclusively digitally. It is recommended to all Concurrents to send all mandatory documents via the Circuitenter portal [see paragraph A], so that the Competitor and Drivers need not be prevented from entering the Circuit.

Also, there will be a session of administrative checks in presence [see timetable] at the racing offices located at the Race Control Tower [paddock stair block n. 1] uniquely reserved to manage eventual pendings.

3) TECHNICAL SCRUTINEERING:

As per the regulations, pre-race scrutineering will be conducted in presence accordingly with each category's sporting regulation.

Only the Clothing Declaration [DA] must be sent to the Organizer via Circuitenter portal before Thursday September 26th 2024 [to be downloaded from acisport.it].

The documents to be sent via Circuitenter must be labelled as follows:

4) TEAM MANAGERS' AND DRIVERS' BRIEFING

The briefings will be held at room n. 17, placed at the 1st floor of the race control tower, paddock stair block n. 4.

5) TRUCK EXIT - DISMANTLING OF THE STRUCTURES

We remind all participants that the dismantling of structures and the movement of vehicles may take place - for safety reasons - only at the end of the last scheduled race.

E) EVENT LOGISTICS

1) CIRCUIT ENTRANCE

Access to the Paddock is free, in compliance with the legislative provisions in force at the time.

2) PASS DISTRIBUTION FOR COMPETITORS AND SERVICES

Access to the Paddock is free, so only Service Passes (no "Paddock" passes) will be provided (Pit Lane and Pit Wall, Media, etc.).

The distribution of Service Passes for Competitors will be carried out at the Security Point (ph. 039 2482241), located at the entrance of paddock 1:

- For EURO4 teams, from Wednesday October 2nd 2024;
- For the other teams, from Thursday October 3rd 2024.

3) GRID ACCESS

Everyone is allowed on the grid with the limitation of access to children under 16 years of age.

4) ACCREDITATION CENTRE

The accreditation centre, located in Via C. Cattaneo 88c, Lissone, will observe the following hours:

- Saturday October 5th 2024 from 08.00 am to 06.00 pm
- Sunday October 6th 2024 from 08.00 am to 03.00 pm

Team/clients may use the delivery service for a maximum of 10 envelopes, which must:

- Be closed;
- Carry the sender (team/client) name;
- Guest's name and surname;
- Name and number of a representative to be contacted in case of need;
- Number of Parking Pass/Tickets contained in the envelope.

It is further requested to fill out a form reporting an alphabetically ordered list of the envelopes and a space for the signature of the collector (it is compelling to show an ID document).

5) TRANSPONDERS' DISTRIBUTION

Transponders must be collected by the Team Representative at the timekeeping room, located at the 1st floor of the Race Control Tower (paddock stair block n. 1) at the following times:

F) CIRCUIT LOGISTICS

1) OVERNIGHT STAY AT THE CIRCUIT

The overnight stay at the Circuit of Motorhomes, campers, or appropriately equipped vehicles is allowed in the dedicated spaces.

2) TELEVISION SIGNAL DISTRIBUTION

3) AUDIO-VIDEO BROADCASTS

4) PADDOCK ACCESS: REGULATION FOR SET-UPS AND TEMPORARY STRUCTURES' CERTIFICATION

Starting from Wednesday October 2nd 2024, paddock areas will be declared "Working Areas" for all the period of set-up/dismantling of all temporary structures.

Work operators must register to the Security Point (tel. 039 2482241) and receive an access pass, in order to access the paddock.

Furthermore, it is available at the following [link](#) the info letter regarding the procedure to be followed for both the set-up and the dismantling phases.

Transportation of materials and/or movement of heavy vehicles are not allowed during night hours unless specifically authorized by the Circuit Management.

During the weekend, access to the main paddock for loading and unloading of materials will only be allowed for a maximum duration of 45 minutes with the issuance of a delivery pass, to be requested at the Security Point.

5) TRUCK WASHING

Truck & material washing is allowed only within the area identified as the "washing area" ([link](#)).

6) MUNICIPAL BILLBOARD TAX
